
CONDITIONS UNDER HAZARDOUS WASTE :

15. Applicant shall have to comply with provisions of Hazardous waste (Management, Handling & Trans boundary movement) Rule-2008.
16. The applicant shall obtain membership of common TSDF site for disposal of Hazardous Waste as categorized in Hazardous waste (Management, Handling & Trans boundary movement) Rule-2008.
17. The applicant shall obtain membership of common Hazardous waste incinerator for disposal of incinerable waste.
18. The applicant shall provide temporary storage facilities for each type of hazardous Waste as per Hazardous Waste (Management, Handling & Trans boundary movement) Rule-2008.

GENERAL CONDITION :

19. Adequate plantation shall be carried out all along the periphery of the industrial premises in such a way that the density of plantation is at least 1000 trees per acre of land and a green belt of 10 meters width is developed.
20. The applicant shall have to submit the returns in prescribed form regarding water consumption and shall have to make payment of water cess to the Board under the Water Cess Act- 1977.
21. In case of change of ownership/management the name and address of the new owners/partners/directors/proprietor should immediately be intimated to the Board.
22. The applicant shall however, not without the prior consent of the Board bring into use any new or altered outlet for the discharge of effluent or gaseous emission or sewage waste from the proposed industrial plant. The applicant is required to make applications to this Board for this purpose in the prescribed forms under the provisions of the Water Act-1974, the Air Act-1981 and the Environment (Protection) Act-1986.
23. The applicant also comply with the General conditions as per Annexure - I attached herewith (No.1 to 38) (whichever applicable).
24. The concentration of Noise in ambient air within the premises of industrial unit shall not exceed following levels:
Between 6 A.M. and 10 P.M.: 75 dB(A)
Between 10 P.M. and 6 A.M.: 70 dB(A)
25. Applicant is required to comply with the manufacturing, Storage and Import of Hazardous Chemicals Rules-1989 framed under the Environment (Protection) Act-1986.
26. If it is established by any competent authority that the damage is caused due to their industrial activities to any person or his property, in that case they are obliged to pay the compensation as determined by the competent authority.
